

Official Rules

1. Project Infinity's Twenty-WON Split Pot Raffle will start at 12:01 a.m., January 23, 2021 and end at 8:00 p.m., February 21, 2021.
2. Must be eighteen (18) years or older and legal US resident at time of raffle entry purchase.
3. Immediate family/household members and officers of Project Infinity, Inc. are ineligible to play.
4. The number of eligible entries received determines the odds of winning.
5. This is a 50/50 split pot raffle. The winner wins a cash prize of half of the raffle proceeds, which equals the total amount of ticket sales minus any expenses. The winner will collect half of the proceeds as described above and Project Infinity, Inc. will keep the other half.
6. The winner will be selected at random at 8:21 p.m. on February 21, 2021 by [RallyUp.com](https://www.RallyUp.com) and will be notified via email on February 21, 2021.
7. Winners must comply with all terms and conditions of these official rules, and winning is contingent upon fulfilling all requirements.
8. The prize will be mailed to the winner to the address listed at time of purchase.
9. If a potential winner of any prize cannot be contacted, fails to reply to the notification email within the required time period of thirty (30) days, or prize is returned as undeliverable, potential winner forfeits prize.
10. In the event that a prize winner is disqualified for any reason, the prize will be awarded to an alternate winner by random drawing by RallyUp.com. There will be one (1) alternate drawing after which the applicable prize will remain unawarded.
11. Winner is responsible for all taxes and fees associated with prize receipt and/or use.
12. By receipt of prize, winner agrees to release and hold harmless Project Infinity, Inc., sponsor, and their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies and each of their respective parent companies and each such company's officers, directors, employees and agents (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Promotion or receipt or use or misuse of any prize winnings.

Project Infinity, Inc. reserves the right to cancel, suspend and/or modify the promotion, or any part of it, if any fraud, technical failures or any other factor beyond administrator's reasonable control impairs the integrity or proper functioning of the raffle, as determined by administrator in its sole discretion. In such event, administrator reserves the right to award the prize at random from among the eligible entries received up to the time of the impairment.

The released parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants or by any of the equipment or programming associated with or utilized in the promotion; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the promotion; (4) technical or human error which may occur in the administration of the promotion or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the promotion or receipt or use or misuse of any prize. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the raffle, provided that if it is not possible to award another entry due to discontinuance of the promotion, or any part of it, for any reason, administrator, at its discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the prizes offered herein. In the event that production, technical, seeding, programming or any other reasons cause more than stated number of prizes as set forth in these Official Rules to be available and/or claimed, administrator reserves the right to award only the stated number of prizes by a random drawing among all legitimate, unawarded, eligible prize claims.

15. Winner agrees to allow Project Infinity, Inc. to publish his/her name and photographs on the Project Infinity, Inc.'s website and social media account/pages.
16. Participation constitutes entrant's full and unconditional agreement to these Official Rules, sponsor's and administrator's decisions, which are final and binding in all matters related to the promotion. Winning the prize is contingent upon fulfilling all requirements set forth herein.
